The import process also includes each standard in PDF form (as released by NERC) and if applicable, the NERC RSAW files.

Update Service subscribers receive an email notice on an approximately monthly basis as new NERC standards and RSAWs are available to update AssurX. The prepared files are accessed through a link to the AssurX Customer Download Site.

Using AssurX's import utility, the new and revised standards and any NERC attachments are automatically imported into AssurX. The update process is easily configurable to work with any unique configurations made to AssurX.

The utility's User Guide details quick steps to accommodate custom configurations with simple changes to the Standards Import spreadsheet. The import utility does the rest.
