MANAGE SUPPLIER ACCOUNTABILITY

The AssurX platform enables secure connection to your suppliers and contract manufacturers that allows you to assign and monitor:

Action Items: Assign Supplier Corrective Action Requests (SCAR) directly to your suppliers to maintain compliance and stay ahead of potential issues while tracking all information in a centralized system.

Quality Certificates: Enable suppliers to upload their own certificates and quality policy information directly into the system via the Supplier Quality Portal to improve speed and accuracy.

Scorecard Visibility: Manage your approved supplier lists with specific information related to each supplier and configure scorecards to monitor and rate your monitor your suppliers' performance.

Policies and Documentation: Automatic notifications and reminders keep suppliers aware of any updates and changes to policy, quality agreements, procedures and specifications.

Incoming Inspections: Issues detected during inspections of incoming material, parts, sub-assemblies, or raw materials can generate immediate investigations into problems. Follow trend analysis to identify consistent issues with parts and suppliers and take appropriate actions.

Business Performance Metrics: AssurX SQM has built-in dashboards, metrics, and real-time trending and analysis. Dashboards let you drill-down to identify potential risks and issues and initiate corrections.

Electronic Signatures: AssurX SQM is 21 CFR Part 11 compliant for FDA regulated companies, or for those that require an audit trail and electronic signature capability.

Automatic Escalation & Notifications: Automated escalation rules, notifications and email alerts keep processes in motion and prioritize critical issues. Establish business rules that ensure timely detection, escalation and notifications of problems before they become serious issues.

INTEGRATION WITH ADDITIONAL QUALITY PROCESSES

The AssurX Quality and Compliance Management platform serves as a single point of control for issue management across the quality chain. SQM is designed to be highly configurable to enable seamless process integration with other solutions in the AssurX platform. Uniting additional solutions creates a greater likelihood of CGMP compliance and operating in a state of control.

Training Continuity: Confirmations and reminders are configured to assign necessary training and policy reviews as required, completed and signed off.

Nonconformance/OOS Tracking: Identify, flag and investigate supplier nonconformances and other quality issues resulting from inspections, audits and other means from intake through resolution.



CAPA: Assign actions directly from the audit record to identify and eliminate the causes of non-conformities or other quality issues.


ENTERPRISE SYSTEM INTEGRATION
